Visual Capital Improvements

Banners – **A. Clores** reported the banner replacement pricing. 30x60 qty12 @ \$59.50/banner. 18x36 qty 100 @ \$48.50/banner. UV cost is \$10-12/banner and is included in cost, estimated to last 2-3 years.

MOTION: to accept Banner Bid – A. Clores Second by: F. Patti- APPROVED ACTION: S. Koperweis to continue to investigate adding 71 banners to Hudson Lights. Check into how to secure without scratching pole and pass stress test.

Marketing- **D. Glenon** reported updates to Fashion Week. Fashion Week will run from May 7th – 12th. The Chamber will be running a schedule of events beginning on Thursday, May 10th and ending on Saturday, May 12th. 40 merchants within the Business District are signed up to

participate in promotions during Fashion Week. The outdoor billboard on RT 46 is completed and will be up the first week of April. There will be several multimedia efforts via social media, video and publications. There will be a separate URL and webpage the Borough is running. The landing page with have the redirect links to other sites promotion Fashion Week. There was a conversation about the approval of marketing designs and branding of Fashion Week. ACTION: Deadline for marketing schedule of outside vendors and 2 sponsors has to be determined by end of March.

Hudson Lights Signage

Contract will go through the BDA. Once received, 2 bids and designs will be presented to the Visual Improvement Committee for final decision. Lights to help brighten darker areas around Hudson Lights better to buy verses rent. No budget to add lighting this year. This will have to go through the sign committee. Tucker, Hudson Lights Landlord talked to 3 companies to brighten up Laser Billboards, cost is 40/50k. There is a new management company at Hudson Lights.

Maresca mentioned there is no way to give an approximate bid because it depends on the size of the storm. At this time there is no budget for this to be done.
