*Visual Capital Improvements:* **T. Clores-**spoke to sharp re: the digital signage that is supposed to go where the clock was. This sign may need approval from the DOT.

We will not do any planting or maintenance, as that is her responsibility. **N. Chape'** will contact her and have a conversation.

### Marketing:

**D. Glennon:** Quite January-no social media stats to note. We tested Dinner and Movie promo with the Barrymore theater. Baggio's or In Napoli's (Pre-Fixe) and a movie (Moonstruck) for \$ 40. It is our intention to partner with them during our 2023 promotion plan. All promotions we do we will try to partner with them thematically. We are working out the details for the rest of the year and a promotion plan will be available for the board next month. We are looking to optimize the Artisan Markets somehow this year.
